**2<sup>nd</sup> -5<sup>th</sup> GRADE**

*HEP A- 2 DOSES (optional)*

6<sup>th</sup>-12<sup>th</sup> GRADE

*TDAP- 1 DOSE*

*MENACTRA (MENINGITIS)- 1 DOSE*

*VARIVAX (CHICKENPOX)- 2 DOSES*

*HEP A- 2 DOSES (optional)*

*HPV(females)- 3 DOSES (optional)*

*HPV INFO LETTER- required to be sent home to 2010 5<sup>th</sup> grade girls and / or 2011 6<sup>th</sup> grade girls.*
